
#### Snapshot

Revo Fitness enlisted the expertise of Australian Payroll Advisory to assess their payroll environment, ensuring compliance with regulations and offering recommendations to mitigate potential risks.

Revo Fitness has a mission to create a gym environment that encourages a healthy relationship with every person's lifestyle and fitness goals, accessible locations, flexible opening hours & affordable memberships.

Compromising of 38 clubs nationally with a pipeline to hit 52 locations by the end of 2024, Revo Fitness currently records over 700,000 workouts each month and is only growing.

## Challenge

The Payroll Manager (Wayne) took a proactive approach to ensure that Revo Fitness met all compliance requirements under both State and Federal payroll legislation, as well as within their specific industrial framework. This involved verifying the accuracy of salaries, hourly wages, penalties, rates, and other entitlements.

Given Revo Fitness's longstanding membership with the Australian Payroll Association, Wayne saw engaging their Advisory team as a natural choice for this task, considering APA's reputation as a leader in the Australian payroll field.

In contrast to larger firms, Wayne valued APA's exclusive focus on payroll services, which distinguished them from the "big 4" vendors.

#### Results

The compliance review delivered several significant outcomes:

- Enhanced understanding among the executive team regarding the depth of tasks involved in payroll functions, fostering a greater appreciation for diligence and verification mechanisms.
- Reinforced the pivotal role of Payroll within the Revo organisation to the executive team.

As a result of the report, Wayne now possesses increased confidence in the accuracy of employee payments, enabling him to approach payroll processing with a greater sense of assurance. Additionally, the recommendations provided in the report have contributed to refining payroll procedures by introducing additional controls and checks.

Wayne's expectations were surpassed by the smoothness of the engagement process and the clarity of the report, alleviating any concerns he had about presenting the findings to the executive team.

Exploring further opportunities with APA, Wayne expressed interest in APA's capabilities in technology procurement and system implementation support, which could be relevant for future endeavors.
